I. INTRODUCTION

POCL 648, Issue I, has been produced to clarify the definitions of terms, abbreviations and acronyms that are used in the rail industry, with particular emphasis on what Owners require to know.

2. INSTRUCTION

The definitions of terms, abbreviations and acronyms are listed in the following Table in alphabetical order. For clarity of communication the listed terms, abbreviations and acronyms should be used in all documentation, correspondence, procedures, etc.

The VCG determines whether or not Statutory Legislation and mandatory requirements have been complied with and issue certification.
